## **1.- SUBJECTIVE AND GEOGRAPHICAL SCOPE**

## 4º.- MECHANICS

The action has a draw mechanics and will take place as follows:

1.- A landing page of the competition is enabled https://concursosvincci.com/quiz-sensory-fitur-2025/, within the domain www.concursovincci.com.

2.- To take part in the competition on this landing page, participants must fill in a form with their full name and e-mail address. Then, on the same landing page, participants will need to **answer 10 multiple choice questions** (with just one correct answer) related to Vincci Hoteles. **PROVENANCE OF THE DATA:** The personal data that we process at VINCCI HOTELS comes from the person concerned, who provides it voluntarily for participation in the competition.

The categories of data processed are:
