

LEGAL BASES OF THE DRAW: THE WINNING HANDS. WHICH HAND WILL WORK ITS MAGIC FOR YOU? FITUR 2026.

To take part in the prize draw, participants must first register using the form that enables them to be included in the mailing list for the Vincci Hotels newsletter and, therefore, be included as participants in the prize draw.

1. SUBJECTIVE AND GEOGRAPHICAL SCOPE.

Any person of legal age who participates in the competition held at the Vincci Hotels stand during FITUR 2026 is eligible to participate in the prize draw. All staff of the company organising this promotional activity, as well as their relatives, are excluded from participation.

4. MECHANICS

1. A QR code will be provided that redirects to the competition landing page <https://concursosvincci.com/fitur2026/>
- 2.- To participate in the contest on the landing page, participants must fill in a form with their true details, including their first and last names, age, email address, province and country. Only one entry per email address is allowed. Next, on the same landing page, participants are given the option to vote for their favourite among the 30 hands, choosing only one.
- 3.- At the end of the participation period, 10 winning hands will be chosen, one winning hand for each prize.
- 4.- Finally, in the week of 26 January, the 10 hands with the prizes will be announced (each winning hand has one of the listed prizes, a total of 10 hands and 10 prizes) on Vincci Hotels' social media, and among all the participants on the list for each hand, ten different draws will be held (one per hand) to determine a winner for each hand.

SOURCE OF THE DATA: The personal data we process at VINCCI HOTELES comes from the data subject themselves, who voluntarily provides it for registration in the Newsletter and to participate in the prize draw.
